 - b. The analysis should include four sectors:
 - i. the private sector investment,
 - ii. venture capital community required for early stage seed capital and the development of innovations requiring investment,
 - iii. the larger private sector infrastructure funds and
 - iv. the public sector grant funding regime at a national, regional and transnational level.
- b) An **analysis of the regulatory development** in South Ostrobothnia and Finland, and integration of the innovation requirements into the policy framework. The analysis should lead to recommendations on how the Regional Strategy of **South Ostrobothnia** can be improved to integrate with the funding requirements.
- c) Development of the **regional action plan**.
